#### I submit my report as under:

- The Company had, on November 22, 2019, completed the dispatch of the Notice of Postal Ballot & E-Voting along with the Explanatory Statement as required to all its equity shareholders whose name(s) appeared on the Register of Members/ List of Beneficial Owners as on the cut-off date, i.e. November 15, 2019.
- The Postal Ballot, in this regard, has been conducted in accordance with the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended. The Company had also provided e-voting facility in terms of Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as an alternative to its shareholders and had engaged Central Depository Services Limited (CDSL) for this purpose.

- The voting through Postal Ballot and e-voting had commenced on Wednesday, November 27, 2019 at 9.00 a.m. and ended on Thursday, December 26, 2019 at 5.00 p.m.
- 4) After the time fixed for closing of the Postal Ballot and E-voting process, i.e. December 26, 2019 at 5.00 p.m., I have downloaded the data of E-voting from CDSL. A Final report was tabulated by me and the data regarding the final E-Voting was diligently scrutinized and reconciled with the records maintained by the Company.
- The particulars of all Postal Ballots and Electronic votes received from/cast by the equity shareholders have been entered in the electronic (excel format) register separately maintained for the purpose.
- The Postal Ballot Forms were scrutinized and the shareholding was matched/ confirmed with the Register of Members of the Company / List of Beneficial Owners as on November 15, 2019.
- 7) All Postal Ballot Forms and e-Votes received up to 5.00 p.m. on December 26, 2019, being the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- 8) I have not found any defaced/ mutilated Postal Ballot forms.
